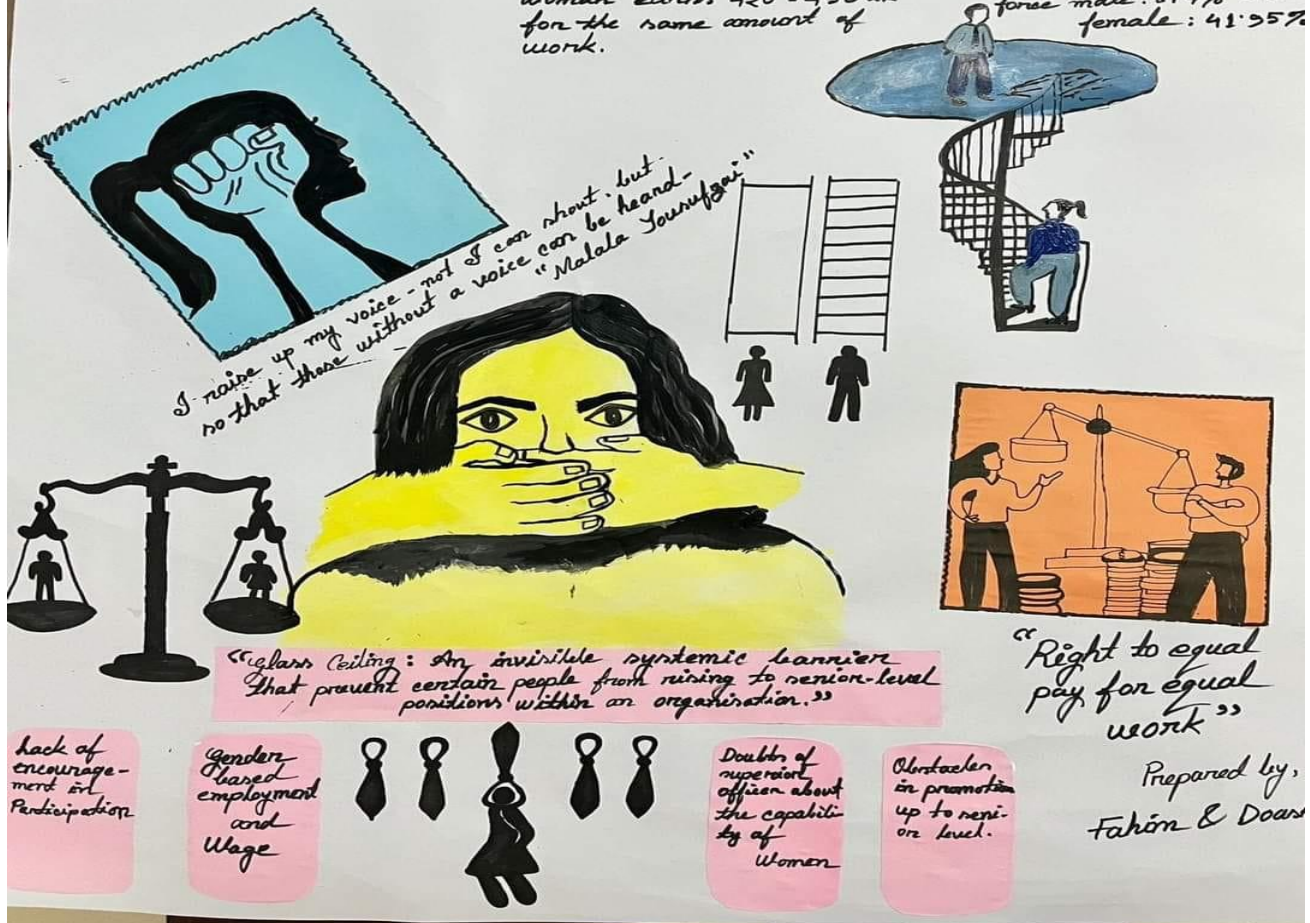
An Evaluation of her Rights: Glass Ceiling Approach and Gender Discrimination

* Where, the Article 23(2) of UDHR ensures the right to equal pay for equal work. But in Bangladesh men earn tk 500-550 and woman earns 420-450 tk for the same amount of work.

* Article 28(2) of our constitution ensures the equal rights of men and women in all spheres of life. But the rate of the participation in labour force male: 81.7% and female: 41.95%.
