12. Rationale of the Course : This course aims to enable students, through the study of cases, statutes and other materials, to acquire a comprehensive knowledge and understanding of, and competence in,

equity principles. Law of equity is an ethical jurisdiction as well as sometimes it uses as a synonym of natural justice. On a more legalistic level, however, equity is the branch of law that was administrated in the court of chancery prior to the Judicature Act, 1873 and 1875. This was a jurisdiction evolved to achieve justice and to overcome the rigorous and deficiencies of the common law. This chancery courts principle had a great influence and, in some cases, it has been incorporated in our legal system as a principle of justice and fairness. The principles of equity also included in different statute of our country. This course also introduces the students to the jurisdiction of the law of trust. The concept of trust is a major emanation of equity; as a result, this part also examines the nature of trusts and the rights and obligations to which they give rise. This course also aims to enable students, through the study of cases, statutes and other material, to acquire a comprehensive knowledge and understanding of, and competence in the law of trusts.

13. Course Objectives:

The objectives of this course are as follows:

- a) To enable the undergraduate students to gain a better understanding of the concepts, origins of Equity, Equitable Remedies and application of equity.
- b) To enable to explain and explain the accurate legal terminologies on trust, classification of trust, duties of trustees and creation of trust, complex legal questions and problems related with trustees and Beneficiaries.
- c) To enhance the capacity of students to find out the cases of breach of trust and remedies thereof.
- d) To Demonstrate the circumstances under which a trust may be extinguished.
