This also deals with different types of government and discusses the essential elements, nature, advantages and disadvantages of various types government. It elaborately explains the organs of the government and helps the students being able to develop necessary critical thinking skills. The overlapping and supplementary relationships between Law, Politics and Government is also ventured thoroughly in this course. Students will be able to critically analyze the concept of politics, political parties and electoral system of the state. This course will help the students to develop the necessary socio legal sense which helps in clarifying the complexity of the relationship between law and society.
